I just do not want to believe it's almost September. But, we still have some time to enjoy our beautiful sunshine!

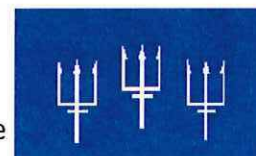

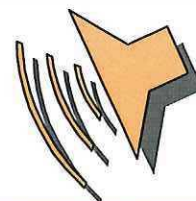

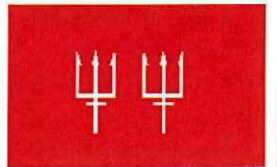

# Boating is fun ~ we'll show you how

**Upper Detroit River "No Wake" Zones from Lake St. Clair**

**Belle Isle "North Side" No Wake**  
**Belle Isle "South Shore" No wake within 200' of shore**

**Detroit - No Wake within 400' of Shore**

**Canadian Side of Peche Island - 5 Knot Speed Limit**

Published by US Coast Guard Auxiliary in cooperation with the Wayne County Sheriff Marine Division and the Ontario Provincial Police. NOT FOR USE IN INTERNATIONAL WATERS. Revised 4-6-2000

Markers "should be" visible in these areas, however, you are responsible to know the law.

**Lake St. Clair "No Wake" Zones**

The Macomb County Sheriff Marine Division describes the rules as follows:

- No wake within 100' from: "Shore. Swimming areas. Swimmers, Anchored boats and rafts."
- St. Clair Shores has their own ordinance in front of the Nautical Mile. NO WAKE zone 600' from shore. This is roughly between 11 Mile Road and the border of Grosse Pointe Shores.
- Speed Limit: Maximum speed of 55mph within one mile of shore.

**Channels & St. Clair River "No Wake" Zones**

These no wake restrictions on the St. Clair River in effect north to Black River in Port Huron

Map not for navigational purposes.

Zones vary depending on the size boat you have.

**No Wake FOR ALL vessels, regardless of size**

**200-600' Rule:**  
 Vessels less than 26' must maintain 200' from shore.  
 Vessels 26' and longer must maintain 600' from shore.

**No wake for vessels 26' and longer. Vessels less than 26' must maintain 200' from shore.**

## Administrative Dept - by Lt/C Gary M. Denolf, AP

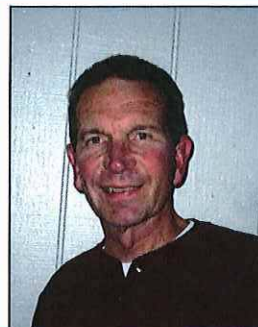
Hi All,
