

Safety Tips from your Editor



Members of the US Power Squadrons

In the event of a medical emergency, boaters do not have the typical 5 – 15 minute response of an ambulance or easy access to the Emergency Medical System. Therefore, it becomes extremely important for each boater to know exactly what to do when an emergency occurs on his or her vessel. Quick and proper response may be the difference between life and death of a crewmember. Both the US Coast Guard and the US Power Squadrons recommend that every boater take a CPR and First Aid Course and be current in these skills.

The USPS will be offering the American Heart Association's Heart Saver First Aid and CPR Course at our Annual Meeting at the Hyatt Regency in Jacksonville, FL. The Course will be offered on two different days – Wednesday January 25 and again on Thursday January 26.


Please note that this course is not the standard course that would be available through your local Red Cross Chapter, Heart Association Training Center or Fire Department. It contains an added section called "Special Medical Concerns and Emergencies for Boaters". A USPS member and USCG Licensed Master, Dr. James A. Brown, JN, wrote this section. Complete information on the content of the course (Course Description) as well as the Registration Form is located in our SailAngle File Cabinet.

The information and form can also be retrieved by sending an email to me at: alankarpas@verizon.net. Please let me know which class you want to attend.

A CPR and First Aid course completion certification is required for anyone wishing to get or renew his or her USCG Captain's License or any USPS member wanting to obtain the Boat Operator Certification (BOC) Certifier rating. All American Heart Association Certifications must be renewed every two years. For those of you who have taken the course in the past, you will find that there have been several changes to the CPR procedures that were implemented on 1 January 2011. The course size is limited and early registration is suggested as this course is very popular and always "Sold-Out". Registration deadline is 14 January.






















































































Administrative Department—Executive Committee


